


### Changes in Net Sales & Ordinary Profit(FY2023 2nd Quarter Results)

(millions of yen/half year)






THAI SEISEN CO., LTD. changed its accounting period (fiscal year-end date) from February to March starting in 2021.

Changes in Industry Shipment Volume(Stainless Steel Wires)




Changes in Sales of Stainless Steel Wires(FY2023 2nd Quarter Results)






## Changes in LME Nickel Price and Exchange Rate



### Changes in Sales of Metal Fibers(NASLON) & Filters (FY2023 2nd Quarter Results)




### Changes in Sales of High Function and Unique Products (FY2023 2nd Quarter Results)










Changes in Sales of Metal Fibers(NASLON) & Filters (Forecast for FY2023)




